1. ANNOUNCEMENT

7. NUMBER OF RIDERS ALLOWED

The maximum number of riders per class allowed will be as follows: Practice: 40 Race: 28

8. ENTRIES AND ENTRY FEE

Applications for entry must be made on the official forms. Applications must be approved by the rider's FMN and must reach the organiser before: 03.May 2015. The entry fee is $\in 80 + \in 5$ (AA Federation) (or equivalent in local currency) per rider. This must be paid at the Race Office on the circuit during the administration registration.

Applications after this date must pay € 50,00 extra entry fee. The organiser will select the applications and advice riders within 72 hours after the closing date of entries whether their applications have been accepted or rejected. Riders must be in possession of a valid licence of the rider's FMN. They must have a written approval of their FMN with an accordance to participate.

9. TECHNICAL INSPECTION

No rider or machine is permitted onto the track unless he/it has passed the technical inspections, which will be held according to the following schedule:

12. RESULTS/AWARDING OF POINTS

Points will be awarded to riders for each Championship entered.

13. PRIZES

The first tree riders in each class for all championship encloused will receive a cup.

14. PROTESTS

All protests must be made in accordance with the requirements of the UEM Disciplinary and Arbitration Code and be accompanied by a fee of: \in 130,-- (or equivalent sum in national currency). Generally, protests against the eligibility of a rider, entrant or a motorcycle entered, must be made before the start of the official practice.

Any other protests must be lodged immediately after the reason for the protest is known.

If the protest entails dismantling a motorcycle, the protest fee must be accompanied by an additional deposit of € 220.- This fee must be paid by the losing party to the mechanic of the rider who had to open the engine

15. FUEL

There will be no fuel supplied by the organiser in the paddock.

16. INSURANCE

By endorsing the application form for entry, the FMN of the rider certifies that the rider is insured in accordance with the UEM requirements.

In conformity with Art. 110.1 of the Sporting Code, third party insurance in respect of riders covering accidents occurring during the event including practices will be the responsibility of the organiser. The organiser disclaims all responsibility for damage to a motorcycle, its accessories and components

arising out of an accident, fire or other cases.

17. RENUNCIATION OF ANY RECOURSE AGAINST SPORTING AUTHORITIES

Apart from the requirements of the UEM Sporting Code, riders by participating, renounce all rights of appeal against the organiser, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the UEM Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of the organiser, his officials, representatives or agents in the application of these regulations or contributed to or arising out of their actions.

Participants Responsibility et Liability

a) Responsibility

The participants (sponsors, drivers, passengers, owners and owner-drivers of vehicles) take part in the event at their own risk. They bear the sole responsibility regarding civil and penal codes for damages caused by them or the vehicle in their use of so far as no liability exemption has been stipulated in compliance with the Supplementary Regulations of the meeting. If the driver, himself, is neither the owner nor the owner-driver of the vehicle used by him during the competition, he releases those persons listed in the following liability waiver from all claims by the owner and the owner-driver of the vehicle or submits, together with the entry form, a corresponding waiver from the owner or the owner-driver of the vehicle.

b) Liability Waiver

By submitting the entry form, the participants (sponsors, drivers, passengers, owners and owner-drivers of vehicles) waive all rights to legal action and recourse for any accident or damage incurred in conjunction with the event against:

- the UEM, the FIM, the FMNR, their presidents, members, employees, sporting stewards and other officials;
- member-club of the FMNR and their sub-organization;
- organizer/promoter, his/their representatives, stewards and assistants;
- the owner(s) of the property used for the event including structures and installations on it, the administration of the circuit used for the event, its representatives and assistants;
- the participants and their attendants as well as against his/their own assistants in so far as a race or special tests for attaining high-speeds or best times are concerned;
- authorities, race services and any other organization or corporate or natural bodies involved in the organization of the event, in so far as the accident or damage did not occur through intent or gross negligence. This agreement will take effect for all parties involved with the submission of the entry form to the organizer.

The undersigned recognizes the above restrictions and commits himself to comply strictly with them, if an injury occurs or is noticed during the event of if the rider's health has been affected such that his fitness for continuing in the motorcycling competition has been put in question ,the undersigned – with regard to the security risk also resulting for third parties – releases the doctors from their obligation to professional secrecy towards the FMNR and towards the officials carrying responsibility at the event (Doctor of the Event,Clerk of the Course, Sporting Stewards) respectively.
